## Are you troubled by



Management Committee member, Dorothy Runnicles, shares her experience.

'About three months ago I reported 2 items of graffiti on my wall to the City Council Graffiti Team and signed the necessary paper for them to act to remove them. About one month ago I reminded them and referred to the items which had grown in number to 7, sophistication, and size during the waiting time. The Graffiti Team managed to remove the offending items after several visits. They also asked neighbours who had been similarly affected to sign forms so that the area could be cleared. The Police treated my report seriously and PC Debbie Miller also visited me to discuss the matter and advise on future action.'

Dorothy offers this advice:

- Owners of affected property should be proactive as soon as possible. The longer
  the graffiti stays the more you get. If the graffiti team can get to you quickly, it is
  easier to clean it off. We need to help the Police as much as possible by being
  vioilant.
- As the local Youth Centre has been closed by the County Council, more detached Youth Workers are needed in the area. Perhaps we need a legitimate graffiti wall for local young artists?
- Dorothy thinks a local community centre for all ages would help increase a sense of community and pride in our area. Responsibility for improving our environment is up to us, and requires individual commitment to action.

## Everyone Welcome!

The Petersfield Area Community Trust is now in its third year. As you can read in this issue of ImPACT, its main activities are to support and defend community interests in local planning issues and in the development of local leisure services and amenities. PACT's core purpose lies in finding ways to address the loss of the Howard Mallett Centre. However, concerns raised at public meetings by PACT members of all ages - as summarised in

the PACT 'Wish List' - have led us also to focus on graffiti, vandalism, and safety in our streets. 'Friends of Mill Road Cemetery' and 'Petersfield Streets for People' are two important new local groups that have developed from or alongside PACT activities.

PACT produces and delivers 3000 copies of this free newsletter, as well as creating information leaflets and maintaining an

acclaimed website (www.colc.co.uk/cambridge/forum/pact). PACT hosts regular public meetings on issues of local concern and at least two widely publicised social events each year. On request, PACT responds to consultations from public bodies. These activities are conducted on behalf of PACT members by a group of 8-10 management committee members who

are elected by and from PACT members at the publicly advertised annual general meeting (AGM). The next AGM will be on 7 November 2001 at St Matthew's Church Hall. The PACT management committee comes together once per month, and forms subgroups that tackle specific issues. This is an enjoyable way to put something

within the wider Petersfield community and we very much enjoy making vital links with other groups in the community.





## **Petersfield Streets for People**

Petersfield Streets for People was formed 18 months ago, in a joint initiative by PACT, Cambridge Cycling Campaign, and Cambridge Green Party.

Two public meetings were held at which local residents put stickers on maps of their own streets to show what improvements they would like to see. Residents told Petersfield Streets for People that they fear for the safety of children, pets, pedestrians, and cyclists, and are generally concerned about traffic, and the feeling that, over the years, our streets have slowly and insidiously been taken from us.


Both meetings expressed sympathy for car-owning residents who need access, but considered changing priorities so that vehicles would have to drive at dead-slow speed and give way to pedestrians. There was feeling against commuter car parking and rat-running. Some wondered whether Petersfield could qualify for one of the new, government-approved, 'Home Zones'.

Petersfield Streets for People has now published a report, based on the findings, which contains scores of practical suggestions for improvements. Copies of the now-published report (an unfinished version was circulated at PACT's AGM last December) can be obtained from John Collins, 158 New Street. Tel. 562364. Members of Petersfield Streets for People have had an exchange of views with Cllr. Colin Rosenstiel and Bob Menzies, respectively Chair of the Joint City / County Transport Committee, and County Council Road Safety & Signals Manager. We would like to see some detailed proposals and consultation by the official agencies, notwithstanding their financial constraints.

We are very pleased they agree that Norfolk Street is a dangerous road, in urgent need of safety improvements. Members of the public and St.Matthew's School parents recently attended an exhibition and consultation exercise with City Council Highways officials and the (County Council) Safer Routes to School initiative, at which the following proposals were on offer (for Norfolk Street): a turning circle for cars; raised tables and traffic-calming measures; closing the East Road exit to cars and improving that junction for cycles; a combination of some or all of the above

A number of attendees made strong representations that a zebra crossing, outside the school, should be included in the proposals and were told by officials that this could be so, the only proviso being that speed humps or raised tables should accompany it to slow down traffic before it reaches the crossing. ## PLANNING NEWS



News on the planning front is not too bad, on the whole. The threat of overdevelopment of sites and consequent pressures on existing residents seems to be diminishing as local residents' groups, guided by Planning Officers, helped by Ward Councillors and supported by PACT, steadfastly resist the worst that developers can throw at us.

Both the Regional Planning Guidance for East Anglia, (RPG6), and Planning Policy Guidance No. 3 on Housing, (PPG3) contain some protection, which we have been able to exploit. RPG6 states that the first preference for housing in the Cambridge sub-region is 'within the built up area of Cambridge, *subject to capacity and environmental considerations*', (our emphasis). PPG3 states 'local planning authorities and developers should think imaginatively about designs and layouts which make more efficient use of land *without compromising the quality of the environment*,' (again our emphasis).

Nine significant developments are already taking place or are in the pipeline within Petersfield. These are at: The Beehive Centre in Coldhams Lane; Philips site in York Street; Foister & Jagg, Abbey Walk; Labgear, Abbey Walk; Simpers, New Street; Ivy Villa, Stone Street; ex-CRC building in Young Street; Carpet Mill, Mill Road and Eastern Court, Newmarket Road/Harvest Way (off New Street).

On the **Beehive site** the threat of a rear delivery road behind York Street houses has gone away! The appeal against refusal of Phase II of the development and in-fill of 'the gap', has been withdrawn. Alternative ways of extending floor space on the site have been explored. In the meantime, Phase I of the development - the ASDA foodstore, bus-turning point and improved security facilities on-site — which, we emphasise, were enthusiastically supported by local residents - are currently under construction. British Land has agreed not to raise the spectre of a service road for another five years from the commencement of a development of a retail warehouse on the former Mazda Car Showroom. PACT will seek to revise the Cambridge Local Plan by strengthening the protection already afforded to York Street residents.

Initial plans for the **Philips site, York Street** were also refused. Wilcon Homes, having 'considered their position', have submitted revised plans. There is some way to go in seeking further improvements to their proposals and they could yet appeal against the refusal. The revised plans went to the Planning Sub-Committee on 30th May and a decision was deferred.

**Ivy Villa, Stone Street**, was the subject of an appeal held on 24th April 2001 against the most recent refusal of plans for this site. The developer has, at the same time, submitted yet another application for nine 3- and 4-bed houses on this small site, hemmed in by existing housing.

This appeal by the developer was dismissed, so residents have won that round! Warm congratulations to Malcolm Hunter, Susan Carlyle, Andy Ranson and John Donaldson and other residents in Stone Street, Stone Terrace and Sleaford Street.

**Eastern Court, Newmarket Road/Harvest Way** is encouraging. Representatives of Fortune Investments met with leaders of RAFT (Residents Against Faulty Towers) and a representative of PACT and were hopeful of putting forward new proposals which residents would be able to support. That will make a welcome change! A public consultation with local residents was held on 25th April 2001 and a follow-up is due in September 2000.

Other PACT activities in general planning issues have included commenting on the draft document on "Conservation of Parker's Piece" and on "Proposed Improvements to St. Matthew's Piece"; and contributing to a consultation workshop on the subject of "Public Participation and the new Council Structure". PACT has also sent a letter to the local Planning Authority on the subject of 'Assessing Density of New Developments' to stimulate debate on this important issue.

Together with our local Ward Councillors, PACT representatives argued the case for "Contributions towards Community Facilities" from new developments in the area and these are now being agreed. We expressed concerns at the current inadequacy of community facilities to cater for the needs of an already densely populated area and pointed out that the rapid expansion, as new residential development goes ahead, will worsen the situation. The City Council's Planning Department has responded positively to our arguments and monies towards community facilities to be contributed by developers will be very welcome. As with the 'Commuted Open Space Contributions' PACT will seek to ensure that local residents are consulted on how these sums are to be spent.

Consultations on Revisions of Cambridge Local Plan should commence this summer. Start thinking about which buildings or sites need protection or which you would like to determine their future e.g. Howard Mallet Centre or The Bath House.

## PACT Millennium Project

By the time you read this, work will already have begun on a new community resource, offering a rare boost to the environmental quality of a neglected corner of Petersfield. Following careful consultation by the City Council with local residents, the drab concrete corner where St Matthew's Street meets Norfolk Street is being transformed into a beautiful Millennium garden.

This project started life early last year, with PACT's search for a suitable setting for the Petersfield Millennium Mosaic. It has blossomed thanks to the sustained enthusiasm and hard work of local residents, vital support from local City Councillors and Officers (thanks, Andy!), and funding from an Environmental Improvements grant and with welcome contributions also from local businesses and residents.

Features of the Millennium Garden will be mosaics created by local people, carefully planned landscaping, improved lighting, and a PACT noticeboard for sharing community news.

The first, almost-finished mosaic is being painstakingly created by some of our more senior neighbours, at the Ditchburn Day Centre on Mill Road. This will become the centrepiece of the Millennium Garden.

For the benefit of future local historians... here is photograph of this corner of St. Matthew's Street in its 'Before' state (not a pretty sight, is it?).

Local residents will have the opportunity to help maintain the flower beds (please contact Anna on 566772 if you would like to help with this or email PACTCambridge@bigfoot.com). This garden is planned to be a source of pleasure for local residents as they pass through on their way to visit friends, the shops or to and from school. It will be a real improvement, particularly on some of the recent uses this corner has seen.

## Where is it at?

PACT has called for local, affordable community activities for Petersfield residents of all ages — and now the City Council Community Development and Leisure Committee, chaired by Councillor J Rosenstiel, is taking steps to find out what is regularly happening in the area. It is aiming to produce a list of current community venues and events together with relevant contact information.

PACT has started them off with a list of all the venues we can think of — so now they will research the rest by contacting local residents, organisations and businesses. Already they have a map with flags indicating venues but we don't want them to miss any!

This mapping process was sparked off by the recent presentation of a petition by PACT, signed by residents following the closure of the Howard Mallett Centre, which stated that:


"Following the closure of the Howard Mallett Youth Centre, young people in the Petersfield area now have nowhere to meet for recreation, leisure pursuits or socialising."

and calling for the provision of:

"a suitable venue for young people in the Petersfield area as an immediate and urgent priority".

PACT has also supplied the City Council with the results of its Survey of Needs, which includes a lengthy list of activities compiled from residents' requests. The first draft of this directory is planned for 6th July 2001. The next step, after listing what is going on in Petersfield, will be to list what isn't.

The City Council's Community Development team will work with Petersfield residents to look at the gaps in provision and to work out what action should be taken to fill them. The City Council is keen to ensure that they don't miss anyone out at this important stage. PACT hopes that all local residents will have the chance to participate in their consultation.


